

What can we do to become more informed of this huge problem right in our own cities and little towns? Each club received a packet of information. Try delivering a few pamphlets at each member's home or dropping one in the mail. Parliamentary Pointers - Virtual Meetings Sandi Conrady, Parliamentary Advisor

Okay... Let's Zooooom! If you are attending your first meeting on the internet, you may be a little apprehensive. It is perfectly natural to be a bit nervous. Once you click on the highlighted site in your invitation and are accepted by your host, you should see your picture and those of the other member that have joined. If you don't see your picture, it might be that your computer does not have a camera. You can still be part of the meeting with only the sound.

So here you are, all ready to participate. As there are usually many participants, you cannot all talk at once (not like sitting in the back of the room visiting with your buddies). You

are actually sitting in the first row! So here are some things to keep in mind:

- Keep your audio in mute until asked to unmute by the host or presenter
- If you need to ask a question there is 'chat' where you can ask a question, etc. Just type in your question and send it. The host or presenter will get you a response.
- You are on camera, so be on your best behavior
- You may be asked to vote and there will be a method to do this on the computer screen
- Time is of the essence (these are not free usually) and there is a time slot for the meeting. So do not take up too much time standing on your soap box.

These are good things to keep in mind even if you are a Zooooomer extraordinaire! And have a good time seeing your friends.

Tips For Asking the Suicide Question

- ◊ If in doubt, don't wait, ask the question
- ◊ If the person is reluctant, be persistent
- Talk to the person alone in a private setting
- ♦ Allow the person to talk freely
- ♦ Give yourself plenty of time
- Have your resources handy; phone numbers, counselor's name and any other information that might help.

Talking with the Suicidal Person

DO'S

- * Ask the question, "Are you suicidal?" or "Are you having thoughts of killing yourself?"
- * Ask if they have a plan
- * Voice concern
- * Tell someone else (NO CONFIDENTIALITY)

DON'TS

- * Leave the person alone
- * Be sworn to secrecy
- * Don't assume the person is venting or it will pass
- * Challenge or dare
- * Argue or debate

GFWC Leadership Education and Development Seminar (LEADS)

The GFWC Leadership, Education, and Development Seminar identifies GFWC members at the local level who have the potential and desire to assume leadership positions in their State Federations and/or GFWC on the national level. Participation in GFWC LEADS can help up-and-coming leaders gain the capabilities, confidence, and commitment necessary to pursue and achieve higher offices and serve with distinction.

GFWC LEADS is typically held annually on the day prior to the official opening of the GFWC Annal Convention. The program may include the following:

Overview of public speaking, time management, vision casting, and conflict resolution. Explanation of GFWC resources, materials, and assistance.

Outline of GFWC policies, parliamentary procedure, and protocol.

Discussion of tips and techniques for pursuing personal growth and developing leadership opportunities.

Application Process and Deadline

Each State Federation and International Affiliate may select one LEADS attendee annually.

LEADS Candidate: Return this form, along with two letters of support from active GFWC club members, to your State Federation by the state application deadline.



Criteria for LEADS Participation

It is highly recommended that each State Federation or International Affiliate LEADS candidate meet the following criteria:

- Demonstrates leadership capabilities at the club level as an active club president, club officer, or club project or committee chairman.
- Exhibits a commitment to the Federation.
- Exhibits an understanding of the GFWC mission of community service, illustrated by programs and projects in which she is or has been involved.
- Demonstrates leadership characteristics, including, but not limited to, organization, responsibility, trustworthiness, enthusiasm, and flexibility.
- Exhibits an interest in and willingness to pursue higher leadership positions in GFWC.
- Agrees to share information gained from participation in LEADS with others in the State Federation.
- Understands and accepts potential expenses involved in participation.
- Has not held elected positions at or beyond the state level (this criterion is recommended
 in order to encourage potential leaders at the club level to apply).
- Has not attended a previous LEADS program. Members are eligible to attend only once.

Expenses

GFWC demonstrates its commitment to training leaders by funding a portion of the expenses of candidates who are members of per capita dues paying clubs. State Federations may consider underwriting a portion of an attendee's expenses. LEADS candidates are asked to be responsible for a portion of their expenses as an affirmation of their personal commitment to the leadership development and training. LEADS participants are responsible for making their own travel and lodging arrangements.

State Federation attendees receive:

Stipend of \$250 for travel.

Lodging allowance for half of the double room rate for two nights at the Convention hotel.

Breakfast and lunch during the LEADS program (no registration fee is required).

In addition, GFWC Montana will provide \$500 to help with expenses

Checks will be distributed to candidates upon attendance and completion of the seminar.

GFWC Montana Membership Report Lynn Foreman, President-elect



The membership numbers were obtained from the December membership list that accompanies the annual dues. Two clubs submitted recruitment updates for Summer due September 1, one of reported no change, but at least reported. Four clubs submitted recruitment updates for the Fall reporting which was due December 1st. I encourage you to please complete your Winter report due March 1 and Spring due June 1. In addition to reporting numbers provide information on what you are doing to *retain members, recruit new members, mentoring and recognition*.

We were able to recognize clubs & members with certificates at the Fall meeting.

The "facts" and nothing but the "facts":

State Membership decreased by 4: 2019 - 599 2020 - 595

4 Clubs - no change in membership

15 Clubs - increased membership

7 Clubs - decreased membership

What are you doing to recognize club members? How are you staying in touch with your members during the pandemic – when many clubs are not able to have meetings in person. Do you reach out to members who are sheltering in place – phone call, or sending thinking of you card.

I attended a GFWC Membership webinar on Cyber Clubs. A panel of 5 Cyber Clubs presented on the reason they formed the clubs, what they do, how they do it. It was fascinating. Your Club could encourage and support the formation of a Cyber Club. One Club was called "Birds of a Feather" because they shared common interests; they welcomed members from their own clubs but also reached out across states. Some communicated solely by email (before vitual meetings were available). They decide on service projects that they work on for their respective areas; another club were quilters who worked on Pillow Cases for Christmas giving trees. Cyber clubs provide opportunities for members to participate who are unable to attend meetings because of conflicts (they can meet anytime they agree upon); plus for members like our club has who are seasonal in the summer when our club does not meet.

Give some thought to also sponsoring a Juniorette club in your area. What better way to engage young women to work on a Community Service project which they will receive credit; and open the door for them to become a club member in the future.

In closing "Think Outside the Box" and share. Happy 2021!



A Home Built with Magazine Subscriptions GFWC Deer Lodge Woman's Club

The GFWC Deer Lodge Woman's club was federated in 1904. These early club women took on a challenge to sell magazine subscriptions to raise enough money to build the still functioning club house. Yes, it took a few years—in fact, TWENTY YEARS! Sixty-six club women meet here regularly wearing masks and social distancing. Club women maintain this clubhouse by raising funds through the New to You store. With minimal shopping available for miles, this store provides residents with school clothes, birthday presents, new shoes and a variety of necessities. Covid regulations closed the store for a period of time but donations continued to appear at the front door. Twenty members working two by two sort, iron and tag garments in order to be ready for reopening the store.





A \$10,000 small business grant from the State of Montana helped during the pandemic making it possible to pay utilities and other expenses to keep New to You and the Club House sound.



A craft fair and bake sale help keep this club sound. Tables are rented to local craftsmen to show their wares. The club members make all the goodies for the bake sale. Shoppers can purchase crafts, a bowl of homemade soup or a street taco in a bag. How about buying a raffle ticket for a chance on a fishing trip and/or camping trip? The club provides both of these raffles to help raise funds for club projects.

Due to this past year's restrictions the club has not held a meeting since March 2020 but are anxious to have their sixteen members able to be active in the community soon.

The GFWC Miles City Woman's Club was Federated in 1914 and is now 107 years young. Ella Riveneswas President of GFWC of Montana in 1980-1982. Her daughter, Sigrid Laird lead GFWC of Montana for the 2000-2002 term. Current long-time members are Fran O'Shea joining in 1977 and Dorothy Murnin, current club treasurer, who joined in 1981. Miles City Woman's Club currently has eleven paying members with 4-6 super active members.

Smaller towns thrive when a relationship can be formed for unity. Miles City Woman's Club has formed a strong relationship with the Convent Keepers and the JC's. The Children's Christmas Store has been a favorite project for many years. Gifts, both new and used, are collected throughout the year and stored at

the convent. On the first Saturday in December the club members, the JC's and local librarians come together to provide shopping for children. No items are over \$5. Purchases can be taken to the wrapping stations and, like magic, each shopping child has a bright shiny package and a smile of pride to head out with the purchase. This project would often raise close to \$1000. In 2020 the JC's came to the club's rescue and took over the project. The club would like to see the JC's continue the Children's Christmas Store.

In 1902 the Miles City Library was started by the GFWC Miles City Woman's Club and have continued to be strong supporters of each other. Thus, the librarians come to help at the Children's Christmas Store.

The relationship with the Convent Keeps stems from club members belonging to both organizations. One day a little girl riding with her mother past the convent asked, "Is that where the princesses live?" An idea was sparked. The Convent Keepers and club members began the Disney Princess Party with fairy outfits and Disney princess costumes. Young girls come for a day of being a real princess with polished nails and a Fairy Godmother. "Bippity, Boppity, Boo!" Local high school girls help make this day a huge success.

The Nearly New Shoppe, operated by the GFWC Madison Valley Woman's Club, holds a Silent Auction every two




weeks featuring "The Best of the Best." All items have been donated.

GFWC of Montana

While some districts banned all married teachers, others were willing to employ married women if their husbands were "an invalid in some way." Commenting on the Billings school board's decision to institute a marriage bar in 1927, the editor of the Helena Independent argued that exceptions should be made for "married women whose husbands are invalids or insane and unable, therefore, to provide a living for the family." Nevertheless, he averred that men should take care of their wives. "Single women with their living to make should not be penalized by having positions open to them otherwise taken by women who have married failures."



The Billings Federation of Women's Clubs opposed the 1927 Billings school district's decision to bar married teachers. When the school board refused to reconsider, they recruited candidates to run for the school board on a pro-married teacher platform. All three lost the election.
